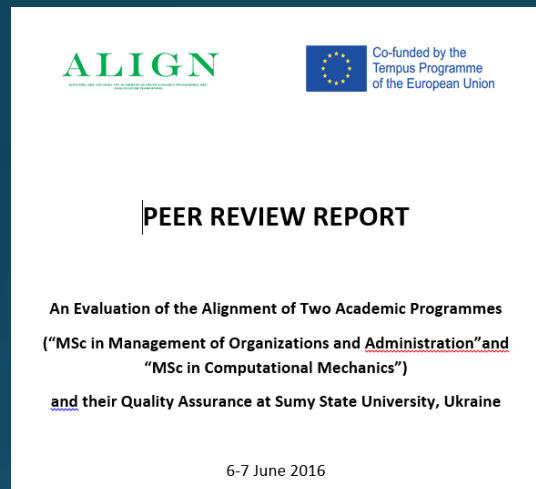
# Main activities of Ukrainian partners

- Analysis of the Peer Review Report, identification of gaps, planning further activities (Action Plans)

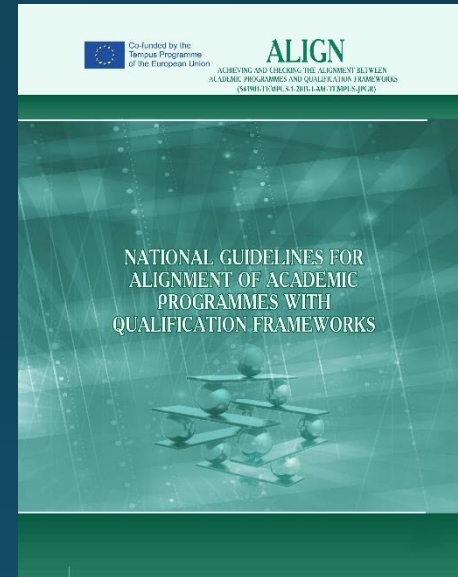


- Development (modernization) of the HEI policies and procedures related to design, monitoring and self-assessment of academic programmes and their quality assurance

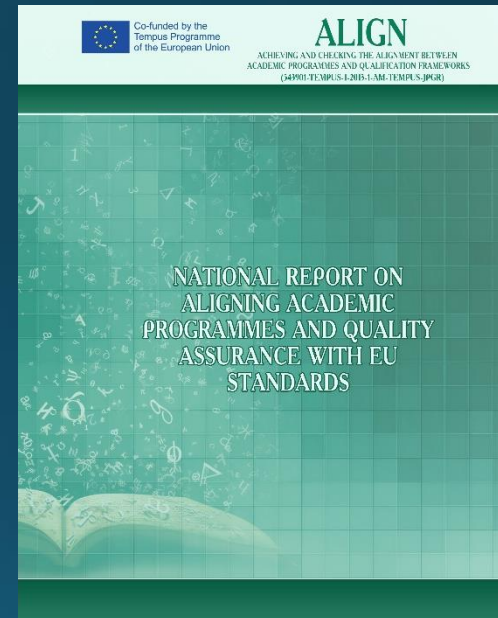
